SAND HAVEN CAMPGROUND PET ADDENDUM

Sand Haven Campground is a family-oriented CAMPGROUND, and we are a safe place for children and grandchildren to visit and enjoy. We want your pet to have fun too! National statistics note a rapid increase in dog bites and insurance companies have acted. As a result, we are requiring all who choose to bring pets to Sand Haven Campground to read and sign the following Pet Addendum before occupying a CAMPSITE. It is Sand Haven Campground's policy that all CAMPERS be allowed quiet enjoyment of the premises. No cat or dog will be allowed that constitutes a nuisance or threat to any CAMPERS(S) or detracts from any CAMPERS(S) quiet enjoyment.

DOG LIMITATIONS:

The following dog breeds and mixed breed dogs containing any of the following will not be allowed. This list is subject to change based on aggressive behavior, state stature, city ordinance or requirements of the Sand Haven Campground's insurance company.

Akita, Chow, Doberman Pinschers, Pit Bull, Rottweiler, and Wolf-Hybird and Cross breeds.

AGREEMENT FOR KEEPING A CAT AND/OR DOG

- 1. CAMPER(S)must comply with all of the following rules and sign this addendum **<u>BEFORE</u>** bringing any cat or dog onto the premises.
- 2. Up to 2 cats or dogs have been approved per CAMPSITE. No other cats, dogs or other animals will be allowed.
- The animal must be licensed yearly or as required by city ordinance and CAMPER(S) must show proof of current rabies and distemper booster inoculations upon registering of the animal. Current copies must be kept in the CAMPING Unit when the animal is present.
- 4. If your pet likes to bark freely, it may not enjoy our CAMPGROUND. Pets creating a disturbance or being a nuisance will not be tolerated. You will be asked to leave the CAMPGROUND and will not receive a refund if you are asked to leave.
- 5. Vicious and/or intimidating animals will not be allowed. If Sand Haven Campground believes that CAMPER(S) animal will pose a threat to the health or safety of others or will cause substantial damage to Sand Haven Campground's property, the animal will have to be removed immediately.
- 6. The animal shall remain inside the CAMPER(S)) unit unless they are on a leash or in a cage for transport purposes. No animals shall be permitted to be loose in yards or other common areas of the facility.
- 7. CAMPER(S) animals are not permitted in the swim area, playground, or rec hall.
- 8. CAMPER(S) are solely responsible for cleaning up animal waste, if any, outside the unit and on facility grounds. CAMPER(S) are responsible for properly disposing of animal waste in the garbage dumpsters. CAMPER(S) shall reimburse Sand Haven Campground \$100 for cleanup of any animal waste each time there is an occurrence. Sand Haven Campground reserves the right to require DNA registration, at CAMPER(S) expense, into DNA world pet registry should the amount of waste not being picked up be deemed ungovernable.
- 9. CAMPER(S) shall take adequate precautions and measures necessary to eliminate animal odors within or around the unit in a sanitary condition at all times.
- 10. CAMPER(S) shall not alter the Campsite in any way, shape, or form in order to create an enclosure for the animal.
- 11. The animal is not to be left unattended for more than 12 hours. If so, CAMPER(S) authorize Sand Haven Campground to enter and remove the animal. Management is authorized to transfer the animal to the proper authority. CAMPER(S) releases Sand Haven Campground from any liability in a case of this nature.
- 12. CAMPER(S)shall indemnify and hold Sand Haven Campground harmless from any claims, causes of action, actions, damages, costs, or expenses of any nature incurred as a result of CAMPER(S) keeping of the animal in the CAMPING Unit.
- 13. Animals may not be tied, leashed, curbed, or otherwise left unattended or attached in any way to a deck, patio, or common area, including, but not limited to storage shed, fences or any other fixtures anywhere on Sand Haven Campground's property.
- 14. Stakes and other grounding items are allowed. Animals may not be left unattended. Any damage caused by grounding items must be repaired by CAMPER(S).
- 15. In the event these rules are not followed, Sand Haven Campground reserves the right to request that the animal be removed from the premises.
